This class will be in person except for our group critiques, which will be conducted online. At anytime we might have to switch to an online only course, so it is important to keep that in mind and prepare for any circumstances.

### **COURSE DESCRIPTION & OBJECTIVES**

This course is an introduction to sculpture concepts and vocabulary through a wide variety of equipment, materials and techniques in the creation of artworks. The course primarily covers welding and woodworking and incorporation of others materials. There are no predetermined solutions to the projects so it is up to you to bring originality, meaning and content to the work.

Throughout the course students should be able to; demonstrate knowledge of names of equipment covered, proper equipment procedures, create sculptures using various techniques and processes, be able to articulately explain the concepts & choices related to their artwork during critique, evaluate and offer criticism of the artwork of other students during critique, document ideas and sketches of their work in a sketchbook and properly document artwork digitally. Because of the pandemic some of these criteria could be altered to adjust to any situation that might occur.

#### **GRADING**

Each project must be completed on time. Critiques begin promptly at the beginning of class. Your work will be assessed the day of the critique. If the work is unfinished, you must present it as it is and it will be graded at that point. All students are required to keep a sketchbook that should contain research notes and sources, project ideas, drawings, observations, printouts, etc. Your sketchbook should be with you at every class. The letter grade I give will be based on:

- creativity openness to experimentation with materials and thought processes
- concept the context and content of your work developed from research
- · craftsmanship attention to details, consistency and structural integrity
- · execution coming to class prepared to work and at least 3 hours a week outside of class work
- presentation how the work is presented for the critique and what you have to say about it
- documentation image quality and ability to follow documentation guidelines

Your final grade will be an average of all <u>projects</u>, <u>class participation</u>, <u>verbal participation during the critiques</u>, <u>attendance</u>, <u>studio activity and your sketchbook information</u>.

### **ATTENDANCE**

You are expected to be <u>on time</u> ready to work when class begins. You are allowed 3 excused absences. More than 3 excused absences will lower your final grade by a full letter grade. You must be present during all <u>critiques and demonstrations</u>. If you are late 3 times it will count as a complete absence.

## **DOCUMENTATION OF WORK**

All your projects must be documented digitally and uploaded to the proper folder on my Google Drive. For each project create a file with your name and load your images and information in it.

## <u>IMAGES</u>

- Images need to be taken with a neutral ground background or an environment relative to the work.
- Images should be taken with your camera **level** to the work either horizontally or vertically. Do not tilt your camera.
- Images must accurately represent the **color and tone** of the artwork.
- Images must be completely in focus.
- Images must be formatted as JPEGs

- Upload 4 views of your final work. First two should be a full views from two different angles & then one or two details.
- · Rename your files:

Video may be uploaded if the work is time-based or involves video, but also provide the still images.

#### **IMAGE INFORMATION**

Provide the label copy information about your work on a separate document.

- Your **Name** (first last)
- Title
- **Date** (do not include month or day, just the year)
- Materials e.g. wood, fur, paint, recycled trash
- Size height x width x depth (this is a museum standard HWD) e.g. 72" x 45" x 35"
- use " for inches and ' for feet
- Brief description of you work and ideas

## **SAFETY**

Follow all rules in the Sculpture Studio Safety Handout. Eye protection must be worn when any tools are in use. Leather boots and natural fiber pants are required for the metal studio work area. Do not wear frayed clothing in the metal studio. Avoid loose clothing. Shoes must fully cover your feet, no sandals. Long hair must be tied back and secured and jewelry removed before using all equipment. Wear ear protection when using equipment. Report any injuries. Do not put any hazardous materials in the sink. Do not use any equipment you have not been trained to properly use.

### **PERSONAL SAFETY ITEMS**

For this class you will need to purchase some of your own personal safety clothing. Because of the health crisis you will not be able to share certain items this semester. Here is the list of items you will need to have to participate in this class.

- · Leather gloves (all leather with no cloth fabric).
- Leather work boots (the tongue also needs to be leather, not fabric).
- Natural fabric pants such as jeans (no synthetic fabric and no frayed clothing).\*
- Long sleeve natural fabric work shirt.\*
- Head covering like a cap or bandana....again, no synthetics.
  - \* A coverall (one-piece suit) with long sleeves will also work in place of a long sleeve shirt and pants and is easier to change into.

- Measuring tape 16 ~ 25 feet
- Utility knife
- ScotchBlue Original Painter's Tape or masking tape approx. 1" wide

# **CONSUMABLE FEE**

This covers shop expendables necessary for this course; welding wire, mig tips, compressed gas, bandsaw blades, abrasive wheels, die grinder bits, drill bits, kraft paper, screws, nails, sand paper, and materials (steel, wood) which will be allocated by the instructor.
